**Re: Affiliation with Motorcycling NSW Limited as a Private Promoter**

Thank you for your expression of interest in becoming an affiliated Private Promoter with Motorcycling NSW Limited.

As an affiliated member, you will be entitled to insurance coverage for claims made by the public in respect of:

- personal injury
- loss or damage to property
- liability of competitors to the public
- liability of insured to competitors
- tenant's liability
- contractual liability

at all race meetings conducted in accordance with the terms and conditions of the Permit.

Permits will only be issued to those Promoters who are affiliated members and on the basis that meetings are conducted in accordance with the General Competition Rules of Motorcycling Australia and the By-Laws of Motorcycling NSW Limited.

An Application for Approval to Conduct a Meeting (Permit Application) is to be accompanied by the relevant fee, together with a bond equivalent to the prize money payable for that meeting.

We would request that you complete the attached application form for affiliation and return to the office, together with the affiliation payment which will be refunded in the event that your application to affiliate is not accepted.

The annual affiliation fee is \$500.00 plus a payment of \$259.00 annually for Directors and Officers insurance and a one-off application fee of \$100.00 (including GST). Membership expires on 31<sup>st</sup> December each year.

Once the completed documentation is received, the application will be tabled at the next Board of Directors meeting which is held monthly and the NSW State Delegates Meeting which is held bi-monthly.

Your application for affiliation will be accepted or rejected at these meetings and you will be notified of the outcome.

If for some reason your affiliation is rejected, the annual fee will be refunded. The application fee is not refundable.
